Our staff and community are dedicated to continually supporting Franklin students in "striving for academic excellence". Franklin Elementary services preschool through second grade children with capacity to educate 640 students annually on a traditional school schedule. In the 07-08 school years Franklin successfully met the academic target goals for two consecutive years and exited Program Improvement. Franklin is a Professional Learning Community in which all persons are learners and focused on student achievement. Our staff and community understand the importance of challenging, supporting and nurturing students in a positive manner, and we encourage parents and the community to become actively involved in the education of our students. Franklin School is a place where all students and their abilities are valued. Staff members are highly qualified and provide an outstanding educational foundation for all students. Franklin School staff members concern themselves with the entire well being of students and promote high academic achievement, acceptable social behavior, as well as emotional and physical wellness. Franklin School is rich in tradition; however, is also one of the oldest schools in our district. We are challenged by limited funding in our efforts to improve the physical aspects of the school and fully incorporate the latest technology. We continue to strive to find better ways to assist our English learners in mastering English language skills so they too may maximize their access to learning.

**School Safety Plan (School Year 2009-10)**

This section provides information about the school's comprehensive safety plan.

The Safety Plan is evaluated and updated on a yearly basis with input from the Merced Police Department, parents, staff, and the community. A district safety team conducts a minimum of one lockdown drill at the site and critiques the drill with the site administrator. The staff conducts quarterly lockdown and monthly fire drills. Teachers and administrators regularly review the rules for safe, responsible behavior in school and on the grounds. We have a closed campus and gates into the school are locked once school begins. Visitors must enter the school grounds through the office and sign and display a visitor pass before entering the campus. Staff members including teachers, instructional aides, administrators, and noon-duty supervisors, supervise the grounds at all times. Gang Intervention Officers that are placed at all four middle schools are always available for support.

Removal of four portable classrooms and adding landscaping where the portables stood. Installing permanent sprinklers on the interior campus grass areas replacing portable irrigation pipes. Installing new playground equipment, enlarging and connecting the woodchip play boxes. Other improvements include the posting of signs in the appropriate areas stating playground rules, bathroom rules, tetherball rules, and school rules. Removal of old trees and planning of new trees between classrooms and on the playground was done. Constructing pathways and gates that align with the natural flow of foot traffic to the classrooms and play ground and the remodel of the front office.

## IX. Student Performance

### Standardized Testing and Reporting Program

The Standardized Testing and Reporting (STAR) Program consists of several key components, including the California Standards Tests (CSTs); the California Modified Assessment (CMA), and the California Alternate Performance Assessment (CAPA). The California Standards Tests (CSTs) show how well students are doing in relation to the state content standards. The CSTs include English-language arts (ELA) and mathematics in grades 2 through 11; science in grades 5, 8, and 9 through 11; and history-social science in grades 8, and 10 through 11. The CAPA includes ELA, mathematics, and science in grades 2 through 11, and for science for grades 5, 8 and 10. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations. The CMA includes ELA and mathematics for grades 3 through 8 and science in grade 5 and is an alternate assessment that is based on modified achievement standards. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations. Student scores are reported as performance levels. Detailed information regarding CST results for each grade and performance level, including the percent of students not tested, can be found on the Standardized Testing and Reporting (STAR) Results Web site. Note: Only a sample group of California's schools and districts participate in the NAEP testing cycle. Therefore, students in any particular school or district may not be included in these results. The NAEP reflects state test results and is not reflective of either the LEA or the individual school. Comparisons of student performance on the NAEP and student performance on the Standardized Testing and Reporting (STAR) Program assessments cannot be made without an understanding of the key differences between the two assessment programs. For example, the NAEP only assesses grades four, eight and twelve and for long-term trends assesses grades nine, thirteen, and seventeen. Additionally, the NAEP only provides state test results for grades four and eight. The California Standards Tests (CSTs) are based on a different set of standards than the NAEP assessments. For example, the NAEP is not aligned with California academic content and achievement standards and, therefore, does not necessarily reflect the curriculum and instruction to which students are exposed in the classroom. The NAEP assesses reading and writing separately, while the CSTs assess English-language arts (ELA), encompassing reading as well as writing conventions, spelling, and grammar. Scores on the CSTs and other assessments are not directly comparable to those on NAEP. The averages and percentages presented are estimates based on samples of students rather than on entire populations. Finally, the questions students respond to are only a sample of the knowledge and skills covered by the NAEP frameworks.
