II. About This School

School Description and Mission Statement (School Year 2009-10)

This section provides information about the school, its programs and its goals.

Fremont Charter School is a neighborhood school, located in west central Merced, serving students in preschool through 5th grade. As the Charter School of the Merced City School District, Fremont offers the families of Merced yet another public school alternative in their children's education. Approximately 44% of Fremont's students live within the schools boundaries and 56% attend Fremont as School of Choice or Administrative Transfer students. Fremont's ethnicity count is reflective of the district-wide population. Our student body is approximately 57% Hispanic, 27% Caucasian, 5% Asian, 8% African-American, and Pacific Islander, 3%. Fremont Charter School is a School-Wide Title I School with approximately 74% of our students eligible for free or reduced lunch. Additionally, approximately 21% of our current kindergarten through 5th grade students are Limited English Proficient, including languages such as Hmong, Spanish, Punjabi or Chinese as their primary, home language. It is the mission of Fremont Charter School to provide a safe, supportive learning environment which values diverse thinking, personal integrity and a productive work ethic. Our school is committed to implementing a rigorous standards-based curriculum, while encouraging life-long learning, self-motivation, personal goal setting, and accountability. It is the primary premise of the Fremont Charter that together, the Fremont Community can and will ensure a quality, public educational experience for each and every one of our students.

Opportunities for Parental Involvement (School Year 2009-10)

This section provides information about opportunities for parents to become involved with school activities.

Fremont Charter School requires parents to get involved with their children's education for a minimum of forty (40) hours per year. This is accomplished by being actively involved in their children's education, helping in the school and participating in various school, parent and community activities such as the English Learner Advisory Committee. The staff of Fremont recognizes that many parents work during the school day or have small children at home and are unable to help in the classroom. However, the following elements are key to ensuring Fremont's

mission to provide a rigorous, quality, standards driven program, and are therefore mandatory to participating in Fremont Charter School: 1. Bringing students to school on time every day in Standardized Dress, ready to learn 2. Student Handbook - reviewing and signing it daily 3. Providing a place within the home to complete homework, including daily reading 4. Reviewing and signing off all homework 5. Parent Teacher Conferences 6. Back to School Night 7. Special Education Meetings (IEP, SST, SOS, SARB) 8. Open House It is the parent's responsibility to record their time on the Activity Sign-In Logs located in your child's classroom, the Library Media & Technology Center or school Office. Students of parents who do not support or fulfill their Home School Contract responsibilities, will be referred to the Personnel Committee for consideration which may include an administrative transfer to another MCSD school. The district will supply the transportation to the new school according to the MCSD transportation policy. Fremont is non-sectarian in its programs, admissions policy, employment practices, and all other operations, shall not charge tuition, and shall not discriminate on the basis of race, ethnicity, national origin, gender, or disability.

III. School Climate

School Safety Plan (School Year 2009-10)

This section provides information about the school's comprehensive safety plan.

Safety of students and staff is a primary concern of Fremont Elementary School. The school is in compliance with the laws, rules, and regulations pertaining to hazardous materials and state earthquake standards. The school's disaster preparedness plan includes steps for ensuring student body and staff safety during a disaster. Fire drills are held monthly while other disaster drills are conducted on a regular basis throughout the school year. Teachers, administrators, and classified staff members all help monitor the school grounds before, during, and after school each day. All visitors are required to check in at the office before entering the campus and wear a visitor's badge throughout their stay. The School Safety Plan was implemented in the 1998-99 school year and is revised and updated annually in order to ensure that it is properly implemented. The plan's policies are reviewed with administrators, staff and student body at the beginning of each school year.

Fremont School is located at 1120 W. 22nd Street in Central Merced. It is situated in an older, but attractive busy area of the community. This location provides the school and its students a safe, somewhat sheltered environment. Area residents take pride in their neighborhood school and provide a watchful eye during non-instructional times. The school grounds at Fremont reflect a safe and inviting appearance. The schools perimeter is lined with a six-foot cyclone fence which maintains a secure area for students. The grounds are maintained in hazard-free condition by the Merced City School District Maintenance Department and the schools custodians. Recent beautification projects such as painting and tree planting have enhanced the school environment. Fremont School is comprised of 5 main buildings which house the majority of the classrooms and offices with approximately 13 portable classrooms. The school design provides features that enhance safety in a secure, physical environment for all students. The school also has a partnership with the Merced Police Department. Campus security is further supported by trained noon-duty campus supervisors who monitor students under the direct supervision of the site administrator. We have crossing guards at R and 22nd Streets, S & 22nd Streets and at the corner of 21st & S Streets. Parents are also encouraged to volunteer to help our staff crossing guards with students.

IX. Student Performance

Standardized Testing and Reporting Program

The Standardized Testing and Reporting (STAR) Program consists of several key components, including the California Standards Tests (CSTs); the California Modified Assessment (CMA), and the California Alternate Performance Assessment (CAPA). The California Standards Tests (CSTs) show how well students are doing in relation to the state content standards. The CSTs include English-language arts (ELA) and mathematics in grades 2 through 11; science in grades 5, 8, and 9 through 11; and history-social science in grades 8, and 10 through 11. The CAPA includes ELA, mathematics, and science in grades 2 through 11, and for science for grades 5, 8 and 10. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations. The CMA includes ELA and mathematics for grades 3 through 8 and science in grade 5 and is an alternate assessment that is based on modified achievement standards. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations. Student scores are reported as performance levels. Detailed information regarding CST results for each grade and performance level, including the percent of students not tested, can be found on the Standardized Testing and Reporting (STAR) Results Web site. National Assessment of Educational Progress

The National Assessment of Educational Progress (NAEP) is a nationally representative assessment of what America's students know and can do in various subject areas. Comparisons of student performance on the NAEP and student performance on the Standardized Testing and Reporting (STAR) Program assessments cannot be made without an understanding of the key differences between the two assessment programs. For example, the NAEP only assesses grades four, eight and twelve and for long-term trends assesses grades nine, thirteen, and seventeen. Additionally, the NAEP only provides state test results for grades four and eight. The California Standards Tests (CSTs) are based on a different set of standards than the NAEP assessments. For example, the NAEP is not aligned with California academic content and achievement standards and, therefore, does not necessarily reflect the curriculum and instruction to which students are exposed in the classroom. The NAEP assesses reading and writing separately, while the CSTs assess English-language arts (ELA), encompassing reading as well as writing conventions, spelling, and grammar. Scores on the CSTs and other assessments are not directly comparable to those on NAEP. The averages and percentages presented are estimates based on samples of students rather than on entire populations. Finally, the questions students respond to are only a sample of the knowledge and skills covered by the NAEP frameworks.
